HOW TO SPOT INJURED WORKERS' FRAUDULENT WORKERS' COMP CLAIMS

- Cross-outs, white-outs and erasures on documents
- Injured worker cannot be reached because he or she is never home or is reportedly sleeping and cannot be disturbed
- Injured worker is seen with calluses on hands, grease under fingernails
- Injured worker moves out of state or county shortly after filing claim
- Accident/incident occurs immediately prior to strike, layoff, plant closing, job termination or job completion
- Injured worker is in-line for early retirement
- Injured worker refuses (or delays multiple times) diagnostic procedures to confirm injury
- Conflicting descriptions of the accident/incident
- Injury is not consistent with nature of business
- Date, time and place of accident is unknown
- Injured worker cannot recall specific details about the injury
- Report of injury not timely and immediate
- No witnesses to accident
- Tip offs from coworkers
